Karen Pestana, Guest Speaker California Bluebird Recovery Project



Karen Pestana is the Bluebird Trail Coordinator for the Tehachapi Mountain Birding Club and monitor for the California Bluebird Recovery Project. She has been a member of the club since its inception in 1998 and has coordinated the trail for 8 years. She received a BS in Biology at the University of Nebraska and began her career with the National Park Service Midwest Regional Science Office in Omaha followed by a move to California where she worked for the California Department of Fish and Game doing research in diverse areas, such as assessing incidental catch in the gill net fisheries for the Marine Resources Division, monitoring least tern nesting colonies for the Non-game Division, and studying salinity tolerances of Salton Sea sport fish. Returning to the National Park Service, she conducted vegetation studies at Channel Islands National Park.

A move to the Tehachapi area (Bear Valley Springs) with her family has involved her in "citizen science", especially with the bluebird recovery program, which she enjoys very much, along with her roles as Girl Scout leader and substitute teacher. We look forward to Karen's program and how we can make a difference in bluebird recovery!

Sunday November 11 - Field Trip PIXLEY WILDLIFE REFUGE

1:30PM - after sunset

If you haven't seen Sandhill Cranes fly into their roosting places at sunset, it is a primeval experience! Join Kern Audubon for this Sunday afternoon/evening field trip where we will also see White-faced ibis, waterfowl, swallows, etc. Meet at the Rosedale Highway Costco near the gas pumps (behind Hungry Hunter restaurant) for carpooling at 1:20 for a 1:30pm departure. We will be out until after dark; bring water & snack, insect repellant (A MUST!), binoculars, small flashlight. Approx. 3/4 mile walk (level gravel road) to observation deck. The cranes fly in at dusk from neighboring alfalfa and grain fields. This trip is for Kern Audubon members only so that we don't overwhelm the cranes. California eBird...is an online bird observation and data recording program developed for birders by Audubon CA, PRBO and the Cornell Lab of Ornithology, which will help with personal record keeping of bird sightings and the scientific community with research into what's happening with birds. www.eBird.org/California provides an easy way for birders, citizens and scientists to enter bird observations into a common databse accessible to those working to protect and restore habitats for birds in California. All you have to do is register on the website as a new user and follow the instructions. When you record your own bird sightings, you are helping science and conservation AND eBird keeps our lists for us! Interactive maps and graphs are provided. Andrea Jones, IBA Coordinator, strongly recommends that Kern Auduboners get involved by visiting the website and recording our bird sightings!

President Bush Offers Needed Bird Conservation Proposals

Laurel, MD (10/21/07) President Bush has announced new conservation initiatives that would help restore and conserve critical habitat for migratory birds. The policies include a planned conservation bank for endangered species habitat, a state of the birds report from the Interior Department, and international bird habitat protection initiatives.

The Statement of Bob Perciasepe, Audubon's Chief Operating Officer: "President Bush's proposals to boost bird conservation measures at home and abroad address some of the urgently needed assistance for which Audubon scientists have long advocated. While much needs to be done, we welcome the President's leadership. We look forward to working with him on these important bird conservation proposals. We also need to continue work to strengthen the Clean Water Act, restore and expand wildlife refuges, recover endangered species, invest in ecosystem restoration and end our dependence on fossil fuels."

VICTORY! Condor Protection Law Signed

Calls, letters, and e-mails from Audubon members throughout California helped push Gov. Schwarzenegger to sign AB 821, the Condor Preservation Act, on October 13. When the law takes effect, it will prohibit the use of lead ammunition for big game and varmint hunting in the areas of California inhabited by the endangered California condor.

The law is needed because lead poisoning caused by eating big game gut piles and varmint carcasses left behind by hunters is a

major source of condor mortality, threatening the millions of dollars invested in condor recovery.



URBAN SPRAWL: THE COST AND THE CURE James Kunstler to speak in Bakersfield

"The future will require us to build better places, or the future will belong to other people in other societies."—James Kunstler

On **Wednesday**, **November 14**, **7:00-8:30 PM**, at Cal-State University Bakersfield, in the **Icardo Center** (gym), **James Kunstler** will be speaking to the public about what we need to do now to make our communities livable. **There is no charge for admission or parking.**

Kunstler is the well-known author of *The Geography of Nowhere* (Simon & Schuster, 1993) and *Home from Nowhere* (Simon & Schuster, 1996), He has long been recognized as a fierce proponent of New Urbanism and strident critic of sprawl and the high costs and inefficiencies associated with an automobile-centric culture. Kunstler's latest book, *The Long Emergency: Surviving the End of the Oil Age, Climate Change, and Other Converging Catastrophes of the Twenty-first Century* (2005), expands on his past critiques of suburbia by exploring the economic, political and social changes that will result from the end of access to cheap fossil fuels and the impact this will have on the way we live, work, farm and build.

His topics and approach to them challenge current development trends in the south valley. In the morning he will be speaking to planners and other involved in deciding public policy on development.

LOCAL ACTION NEEDED: SUPPORT MANDATORY CURBSIDE RECYCLING

On November 7, the Bakersfield City Council will take up a proposal that would lead to universal curbside recycling collection. Kern Audubon Society urges the city to approve the measure, which would authorize the city to pursue a \$1.5-million state grant to improve the city's recycling collection and sorting capability. Recycling saves energy and resources, resulting in lower greenhouse gas emissions and habitat protection.

KAS Backs City Habitat Conservation Measure

Kern Audubon Society provided comments to the Bakersfield City Council on October 10, favoring a proposed ordinance to establish a \$500 per day fine for developers and property owners who grade their properties prior to obtaining the necessary permits. Such illegal grading often results in the destruction of endangered species and their habitats, such as Burrowing Owls and the San Joaquin kit fox. The measure was needed to give strength to Bakersfield's Habitat Conservation Plan. Funds generated by the fines will be placed in a fund to be used toward purchase of land for habitat reserves.

<u>ACT NOW TO HELP STOP GLOBAL WARMING—Urge Congress to Pass a Renewable Electricity Standard and Increase Vehicle Fuel Efficiency</u>

The catastrophic effects of global warming pose a tremendous threat to the survival of many of the world's bird species, which is why the Audubon Society has made combating global climate change a top legislative priority.

And we need your help. Please fax, email or phone our US Senators and Representatives McCarthy & Costa. The energy bill is before committee NOW, so responses are needed as soon as possible! Thank you!!

Here's a sample letter to use as a model. Remember, the most effective letters are written in your own words.

RE: House and Senate Energy Bills: Support 15% Renewable Electricity Standard (RES) and a35 mpg Corporate Average Efficiency Economy Standards (CAFE)

Dear Representative or Senator	

Congress will soon convene a conference committee to iron out the differences between the House and Senate versions of the New Direction for Energy Independence, National Security, and Consumer Protection Act (HR 3221), introduced by Speaker Pelosi, and the Renewable Fuels, Consumer Protection, and Energy Efficiency Act of 2007 (HR 6), introduced by Congressman Rahall.

I urge you to support a final bill that <u>combines two vital elements</u> of both the House and Senate versions:

The House provision creates a national Renewable Energy Standard (RES) that would require utilities to generate 15 percent of their electricity from renewable sources by 2020. This standard would boost the production of clean, renewable energy sources such as wind, solar power, biomass, and geothermal, while saving money for consumers, creating jobs, and lowering greenhouse gas pollution.

The Senate version raises the average fleet-wide Corporate Average Fuel Economy (CAFE) standard from 27 mpg to 35 mpg by 2020. This long overdue improvement in gas mileage will save 1.2 million barrels of oil per day, save consumers \$25 billion, and substantially reduce global warming pollution.

The American Council for an Energy Efficient Economy estimates that combining the best elements of both versions would cut global warming pollution by 19 percent and save consumers \$850 billion by 2030.

I urge you to make sure that the version of this legislation that Congress sends to the President includes BOTH a 15% RES and a 35 mpg CAFE standard. I look forward to your reply.
