“California Audubon Conservation Highlights”

Glenn Olson is Vice President and Executive Director of Audubon California. He oversees Audubon programs in California, which include a network of nature centers and wildlife sanctuaries, 50 local Audubon chapters, and more than 60,000 Audubon members. Audubon California recently completed an update of the *2010 Conservation Action Plan* charting Audubon's course over the next 5 years, including major conservation initiatives to protect the most important California landscapes for birds, such as San Francisco Bay, the Salton Sea, and the Mayacamas Mountains region of the Interior Coast Range.

Glenn has been with Audubon for over 30 years, starting his Audubon career as conservation chair for the Los Angeles Audubon chapter and taught at the Audubon Camp of the West in Dubois, Wyoming. Before becoming Executive Director of Audubon Ca, he was Audubon's Western Regional Director. He holds a Master's Degree in Public Health from UCLA and a Bachelor's Degree from the University of California at Santa Barbara. Glenn and his wife, Devon, reside in Sacramento, California. They have 3 grown children.

FOR THE BIRDS...



Nov 7 - Vote Conservation: Yes on Prop 84, No on Prop 90

Yes on Prop 84 - \$5.4 billion conservation and water quality bond. Proposition 84, the Clean Water, Parks and Coastal Protection Bond, is critical to renew funding for the Wildlife Conservation Board, the Coastal Conservancy, numerous regional conservancies, and other important restoration and acquisition programs. Without Prop 84, many of the State's conservation dollars will dry up within the next one to two years, a risk we cannot afford to take. Audubon California is working hard to make sure that Prop 84 passes!

No on Prop 90 - A Tax Payer Trap Proposition 90 is an assault on environmental protection in California. Hidden behind language to stop abuses of eminent domain, Prop 90 includes several dangerous provisions that would drastically cut back on the government and even voters' ability to protect environment, local communities, and farmland. Prop 90 aims to restrict governments' ability to pass land-use regulations by requiring the government to make huge payments to landowners unless the regulation are to protect narrowly-defined public health or safety. Prop 90 would also make it prohibitively expensive for public agencies to acquire property for wildlife, public works projects, new schools, fire protection measures, and utilities. Audubon CA recommends a "NO" vote.

Kern River Valley Earns Hemispheric Recognition

The Kern River Valley and Southern Sierra Nevada is one of two "Hot Spots for Summer Songbird Diversity" in the Western Hemisphere highlighted in the new book Songbird Journeys: Four Seasons in the Lives of Migratory Birds (Walker Press, New York, 2006). Author Miyoko Chu writes, "Summer bird watching is especially exciting where different habitats converge, bringing diverse bird species together in the same region.... California's Kern River Valley and surrounding areas offer spectacular contrasts in landscapes and wildlife, from lush riparian woodlands to the towering sequoias of the Sierra Nevada to the Mojave Desert and foothill chaparral habitats..."

In the three page section of Songbird Journeys entitled "Southern Sierra Nevada and Kern River Valley, California," Ms. Chu refers to the Giant Sequoia National Monument, Audubon California's Kern River Preserve, the South Fork Kern River Globally Important Bird Area as some of the natural areas found in the region. She then goes into some detail on specific birds to look for in different habitats: Great Basin, Mojave Desert, chaparral, forested mountains of the southern Sierra Nevada, and the Kern River Preserve's riparian habitat. The author's writings on the Kern River Valley end with visitor information: WHEN TO GO (April through July), NEAREST BIG CITIES (Bakersfield, Los Angeles), SPECIAL ACTIVITIES (including art, astronomy, birding, festivals, fishing, geology, hiking, plants, rafting, and wildlife). FOR MORE INFORMATION (Kern River Preserve web site), and RECOMMENDED READING (Tips for birding the area).

Miyoko Chu is an ornithologist and staff science writer at Cornell University's internationally recognized Laboratory of Ornithology. She is editor of the Lab's Birdscope newsletter and assistant editor of Living Bird magazine. She lives in Ithaca, New York, with her husband and two children.

Proposed SVRA

The County Planning Comm. hearing on the proposed State Vehicular Recreation Area north of Bakersfield, was scheduled to be heard Sept. 28, with its recommendation to go to the Board of Supervisors on Tues. Oct. 24th. There are serious environmental concerns related to Poso Creek, which runs through the southeastern portion of the proposed park, as well as concerns about air quality and Valley Fever spores from the dust. PROPOSED BAKERSFIELD STATE VEHICLE RECREATION AREA

A draft Environmental Impact Report has been made on a proposed State Vehicular Recreation Area (also known as an Offhighway or OHV park) to be located on 11,000 acres approximately 9 miles northeast of Bakersfield, near the intersection of Round Mountain Road and Adobe Canyon Road. The park would be owned and operated by the California State Parks and would be open during daylight hours 7 days a week for use by all-terrain vehicles, motorcycles and 4WD vehicles. Anticipated use would be approximately 100,000 visitors annually.

The proposed site elevation ranges from about 800 ft to 2800 ft and running from east to west through the site is Poso Creek, the second largest perennial stream in Kern County, second only to the Kern River. The downstream portion of Poso Creek within the project site contains a dense covering of riparian woodland dominated by willows and cottonwoods. and provides suitable habitat for 17 sensitive wildlife species, including 6 federally and/or state endangered and/or threatened wildlife species, in addition to a number of common resident and migratory wildlife species. The draft EIR indicates there are "sensitive biological resources within Poso Creek considered to be valuable to the region, and potential direct and/or indirect impacts to any portions of Poso Creek are considered significant" and would require "mitigation measures."

Other significant "Impacts on the Environment" to be considered: air quality, water issues, access to the site, wildland fire, agriculture.

A hearing has been scheduled by the Kern County Planning Commission to receive public comments on SEPTEMBER 14, 2006, 7PM, Chambers of the Board of Supervisors, Kern Co. Administrative Center, 1115 Truxtun. Though this proposed SVRA is in the "conceptual level" of planning, the Planning Commission WILL be making a recommendation to the Board of Supervisors based on the EIR, written public comments and the staff report. The Board of Supervisors is scheduled to hear the proposal on Tues. October 10, 7pm. Kern Auduboners are encouraged to attend both hearings and/or offer comments to the Planning Commission. Please express your concern about the SVRA's impact on the Poso Creek environment and raise questions about the impact the park will have on our air quality, including dust (Valley Fever spores?!). 100,000 "visitors" on motorized vehicles will have an impact

DESERT TORTOISE NATURAL AREA

The 39 square mile Desert Tortoise Natural Area is found in Eastern Kern County, 4 miles northeast of California City just off the Randsburg-Mojave Road. It is home to California's state reptile, the Desert Tortoise, 29 species of breeding birds, 27 other reptile species and 23 species of mammals. The Desert Tortoise Preserve Committee is planning a Work Party October 28-29 which provides an opportunity for birding as well as getting acquainted with desert tortoise habitat. Tasks for the work party include weeding, fence & trail maintenance, clean-up. LOKERN PRESERVE

Lokern Preserve is one of several small preserves in the southern San Joaquin Valley operated by the Center for Natural Lands Management. The 3000 acre site is located 33 miles west of Bakersfield along Hiway 58. The preserve's terrain consists of flat and gently rolling shrubland and grassland. Vegetation is mixed and hosts a number of endangered animals, including kit fox, blunt-nosed lizard, San Joaquin antelope ground squirrel & Tipton kangaroo rat. The endangered plant species Kern mallow is also present. Preserve Manager Greg Warrick will present a program for Kern Audubon in February on the Center's three preserves as well as leading a field trip. In the meantime, Greg invites persons interested in the small mammal trapping/tagging program, to consider helping out sometime during the week of Sept 25-29. NATIONAL AUDUBON SOCIETY

Is Audubon just about birdwatching? Far from it! The mission of Audubon is ***to conserve and restore natural ecosystems, focusing on birds, other wildlife, and their habitats for the benefit of humanity and the earth's biological diversity.*** To that end, National Audubon's "Agenda 2006" includes these 9 priorities for the 109th Congress:

- 1) Clean water protections by strengthening the Clean Water Act (Proposition 84 in Calif.)
- 2) Protecting birds and wildlife by supporting America's basic conservation laws including the Migratory Bird Treaty Act, Endangered Species Act, National Environmental Protection Act.
- 3) Preserving America's Arctic Landscape--opposing drilling in the Arctic Nat'l Wildlife Refuge which has breeding grounds for millions of migratory birds.
- 4) Protecting our great natural heritage -- bringing back nationally significant places in the American landscape by efforts to reduce pollution, and restore habitat.
- 5) Conserving ocean life--supporting measures to reinvigorate fisheries, prevent overfishing, increasing protections for seabirds and coastal areas.
- 6) Protecting wildlife refuges
- 7) Connecting people with nature through Audubon Nature Centers, such as the Kern River Preserve.
- 8) Investing in birds, wildlife and habitat through funding for federal wildlife refuges, Land & Water Conservation Fund, North American Wetlands Conservation Act, invasive species control programs.
- 9) Helping private property owners help birds and wildlife--support funding for conservation programs in the Farm Bill as well as tax incentives for landowners to protect bird and wildlife habitat.

The Audubon Society has been in existence since 1899 and its first significant event: the Christmas Bird Count of 1900. It has long been one of the most significant grass-roots conservation organizations with over 400,000 chapter members. Thank you for being part of the Audubon legacy!
